ABOUT THE COURSE

The program is a complete, professionally taught Driver Education Course, that will provide students with a comprehensive introduction to the driving experience. Students must complete 16 sessions of in-car and 16 sessions of classroom instruction with a passing grade of 65 in each category. At the end of all 32 sessions (16 car and 16 lectures) students will have received, 24 hours of classroom instruction and 24 hours of in-the-car driving related to "Rules of the Road", traffic safety concerns, defensive driving, proper handling of vehicle, parking, driving in traffic, and problems of substance abuse as related to driving.

WHAT THE COURSE OFFERS

It includes the MV285 "Completion Certificate"; an insurance reduction to students who qualify; a Senior driver's license Class D at age 17, upon passing the DMV Road Test.

ELIGIBILITY

Students must be 16 years old and must have a Learner's Permit before the first class. Students must reside within the Baldwin Union Free School District and have completed their sophomore year of high school. All applications will be handled on a first come, first served basis.

COST

\$455.00. Full payment must accompany the registration form. Please include a check or money order payable to the *Baldwin Senior High School*.

REFUND POLICY

I am also aware that the refund policy is as follows: If a student cannot be accommodated because classes are filled, all monies will be returned or refunded. If a student cancels one week prior to the first class, a \$30 administrative charge will be deducted from the refund. If a student withdraws the day before the first class, only a 50% refund will be granted. Thereafter, no tuition refund will be authorized.

ABSENCES/MAKE-UPS

By New York State Education regulations, a student is allowed to make up no more than 3 absences. It is the student's responsibility to make arrangements with, and obtain prior approval from, the regular driving and/or lecture instructor to proceed with any make-up assignments. More than 3 absences will result in the student being dropped from the program.
